On March 12, 2014, the Chancellor of the Berkeley campus, on behalf of The Regents of the University of California, authorized the Chief Executive Officer (CEO) of the Berkeley Education Alliance for Research in Singapore (BEARS) to carry out various duties on behalf of the Chancellor, including to: (1) oversee and administer the operations of BEARS and (2) file appropriate submissions with the competent local authorities. As the CEO of BEARS, I am re-delegating to you, in your role as Chief Operating Officer of BEARS, my authority to file appropriate submissions with the competent local authorities in Singapore for the following submissions to the Singapore tax authority:

1. Form IR21 Tax Clearance Return for UC Berkeley employee Rachel Taylor for the Year of Assessment: 2015;
2. Form IR21 Tax Clearance Return for UC Berkeley employee Stefano Schiavon for the Year of Assessment: 2015;
3. Form IR21 Tax Clearance Return for UC Berkeley employee Zheng Haimei for the Years of Assessment: 2014 and 2015;
4. Form IR21 Tax Clearance Return for UC Berkeley employee Kameshwar Poola for the Year of Assessment: 2015; and
5. Form IR21 Tax Clearance Return for UC Berkeley employee Fiona Doyle for the Year of Assessment: 2015

This re-delegation of authority is necessary because I have not yet received an employment pass in Singapore and I cannot file submissions with the competent local authorities until I receive my employment pass.
