

**DA2612 - Authority to Execute Amendments, Modifications, and Renewals with Respect to UCB Contract with the California Department of Social Services, Contract No. 16-IA-00775**

Standing Order of The Regents 100.4 (dd) states that:

Except as otherwise specifically provided in the Bylaws and Standing Orders, the President is authorized to execute on behalf of the Corporation all contracts and other documents necessary in the exercise of the President's duties, including documents to solicit and accept pledges, gifts, and grants....

Specific exceptions to the President's authority for matters under 100.4(dd) are enumerated therein.

On April 19, 2012, the President delegated authority to Chancellors, the Lawrence Berkeley National Laboratory (LBNL) Director, and the Vice President of Agriculture and Natural Resources, to solicit and accept or execute extramural grants and contracts for research if direct costs in any one project year did not exceed \$10,000,000 in contracts and grants for which the source of funds originates from a federal or State of California agency, and \$5,000,000 for all other contracts and grants (DA2569).

Because the named project exceeds this limit, the President approved a proposal and contract action, on behalf of the Berkeley campus, with the California Department of Social Services for Title IV-E Social Work Training Program (currently under Contract No. 16-IA-00775).

Effective immediately, as Chancellor of the Berkeley campus, you are authorized to solicit and execute any amendments, modifications, continuations or renewals subsequent to the initial award provided the general intent and purpose of the program remain unchanged from those originally approved. This authority may be redelegated.
