RE: Delegation of Oversight of Police Department During Protest

Consistent with Executive Vice Chancellor & Provost Breslauer's February 21, 2012 message to the campus community, President Yudof's January 10, 2012 letter to the Chancellors, and the recommendations of the September 13, 2012 Edley/Robinson report, this campus has implemented a requirement that, whenever possible, a fully-briefed, on-site senior administrator must authorize police engagement during campus demonstrations and crowd control situations. To date, this responsibility has been fulfilled either by the Associate Vice Chancellor for Business and Administrative Services or the Vice Chancellor for Administration and Finance, both of whom are in UCPD's reporting line.

I hereby additionally authorize the Executive Vice Chancellor & Provost, the Vice Chancellor for Student Affairs, and the Vice Chancellor for Equity and Inclusion to provide oversight of UCPD operations in connection with demonstrations and crowd control events on campus and to approve appropriate UCPD actions necessary to protect health, safety, property, university operations, and the rights of all involved or affected individuals. To the extent circumstances permit, the senior administrator overseeing UCPD operations shall consult with the Vice Chancellor for Administration and Finance and the Executive Vice Chancellor & Provost immediately before authorizing UCPD engagement or escalation of engagement.

The Vice Chancellor for Administration and Finance shall be responsible for assuring that all senior administrators authorized to oversee UCPD protest management receive appropriate training relevant to those responsibilities.
